## Voter Registration



Voter Registration closes 28 days prior to each election. This year a consolidated primary is being held for Elgin and Dundee Township in Kane County. Thus voter registration closed on January 27, 2009. Registration will reopen on February 26 and run thru March 10, 2009 for the Consolidated Election to be held on April 7, 2009.

Grace Period Registration is from January 28 thru February 10. and March 11 thru March 25, 2009. During this period you may register at the Kane County Clerk's Office.

Absentee Voting for the Consolidated election begins on February 26 and runs thru Monday April 6, 2009. Early voting will begin on March 16 and run thru April 2, 2009.


